

## The 25 Days of Cold Stone Contest ("Contest")

### Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY AGREEMENT MAY BE REQUIRED.

**1. Eligibility:** The Contest is open to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the beginning of the Contest Period (as defined in Section 3 below). Void where prohibited by law.

Employees of, members of the immediate family of, or those domiciled with an employee of Sponsor (as defined in Section 10 below) or its affiliated or related companies, and Cold Stone Creamery® licensees and franchisees are ineligible to participate.

**3. Contest Period:** The Contest is begins on December 1, 2013 at 12:01 A.M. Scottsdale, Arizona time through December 25, 2013 at 10:00 P.M. Scottsdale, Arizona time ("Contest Period"). Sponsor's computer is the official timekeeper for the Contest.

**4. Prizes and Odds:** Six (6) Prize categories with a total of one hundred and fifty (150) individual Prizes (each a "Prize" and collectively, "Prizes"): Total Actual Retail Value ("ARV") of all Prizes is Three Thousand Seven Hundred Thirty-Five Dollars U.S. (\$3,735). **6. Notification and Claiming Prize:** Each Prize winner will be notified by email to the winner's email address used to enter the Contest. The eGift Prizes will be emailed to valid winners who have timely returned a completed and signed release to Sponsor.
